Boats or wheeled vehicles, other than passenger vehicles, passenger vans and pickup trucks (as long as any such vehicle has no commercial signs thereon) must be kept completely inside a garage located on the lot. No trailers or habitable motor vehicles of any nature shall be kept for use on any lot except within a fully enclosed garage. Disabled vehicles, vehicles under repair or vehicles in storage must be kept only within the garage located on said lot.
